FABT SEASON 2023/24 Policies and Covid 19 Waiver -Please fill out and sign-

1. General Policy

• To maintain a courteous and professional atmosphere at French-American Ballet Theatre "FABT", all students are expected to conduct themselves in a safe and responsible manner. We ask students to be polite to each other as well as with FABT employees and faculty.

• Waiting areas should be kept clean and orderly. Trash should be placed in proper receptacles. All waiting room accessories (chairs, books, magazines, etc.) should be returned to their proper places after use.

- For safety, personal belongings should be neatly stored in a cubby or against the wall.
- Students must always remain quiet in the waiting room. Roughhouse or do gymnastics are not tolerated in the waiting room or the hallways of the studio.

• All students must arrive to their assigned classes promptly on time. If a client has a conflicting schedule, the instructor or the Artistic Director must be informed of it during the registration process. Students arriving late to class should enter the studio but wait for the instructor's permission to join the class. Students may not leave the class without permission from the instructor.



• All students must have a clean and neat appearance and must follow the dress code when coming to the FABT. Outside of FABT premises but while still in the building appropriate cover-ups should be worn over the class attire. For the Ballet classes, ladies must have hair neatly arranged in a tight bun. It is the student's responsibility to fix their hair.

• Dance shoes should only be worn in the studio, waiting rooms and hallways. Students wearing dance shoes outside will not be permitted to take class in the same shoes. No exceptions.

• No leaning on barres or touching studio mirrors. The dance barres are for educational purposes only. No hanging or swinging from barres; nor should clothes or towels be hung from the barres.

- Food, soda, and chewing gum are not allowed in the dance studio. Water is permitted.
- Cell phones must be turned off at all times.

• No valuables should be stored or left in the dressing rooms during a student's class. To maintain a healthy and sanitary environment, students may not leave dirty dance or street attire in the studio, lobby, or dressing rooms. FABT is not responsible for any items lost or stolen from the school premises.

• All students must be picked up promptly after the end of the classes. FABT recommends that younger students be picked up from the studio premises rather than outside. FABT is not responsible for the client's whereabouts after the scheduled time of classes and/or rehearsals time ended.

2. Ballet Dress Code

Ladies Young Dancers Division:

- Black color leotard, any style - Pink tights - Ballet slippers and Pointe shoes. For new pairs, please leave ribbons and elastics unsewn pending to the Artistic Director's approval - Black skirt accepted.

Gentlemen Young Dancers Division:

- Fitted black, white or grey T-shirt Ballet tights or shorts Ballet slippers.
- Adults:
- There is no mandatory dress code for the Adult Division.
- All levels:

- Neat hairstyle required - Warm-up apparel accepted at beginning of the class - No heavy make-up, nail polish or jewelry

- Absolutely no watch or Fitbit.
